

# OHIO VINTAGE TRUCK JAMBOREE

Letter of Intention & Request of Space

This Swap Meet is to be an avenue to dispose of TRUCK and related items used in preservation of the ANTIQUE TRUCK and the ANTIQUE TRUCK HOBBY, to include memorabilia and toys (die cast, stamped tin, wooden and plastic).

*We wish to not promote the sales of easily obtainable foreign manufactured tools and equipment, -Please do not set-up if those items represent 75% of your sale items.*

INSIDE SPACE: 20' frontage 10' deep-\$25.00 for 2 days- \$15.00 for 1 day

OUTDOOR SPACE: 20' frontage by available depth -\$25.00 for 2 days- \$15.00 for 1 day. Non-refundable Pre-registration fee received by June 1 guarantees space.

*Must be set-up by 8:00 a.m. no motor traffic in buildings after show starts.*

*Early Vendor Set-up (at your own liability) is Friday previous to show starting at 12:00 p.m. till 5:00 p.m.*

*Please no early tear-downs as we are providing the show until 2:00 Sunday.*

All pre-registered vendors agree to be on their space at 8:00 Saturday morning or space will then be made available as first come first serve basis.

Vendors are required to furnish their own tables and chairs.

No Vendor traffic permitted during show hours (9:00a.m.-4:00p.m.)

There is to be a \$50.00 fine imposed (determined by fairground officials) on the vendors damaging fairground's property, or leaving debris, or leaving unwanted items on show grounds. Permission is to be obtained before hanging anything on walls, trees, telephone poles or buildings.

A minimum number of spaces are available with electricity (inquire when pre-registering by noting in the appropriate space below.) Fee \$10.00 for 2 days.

There will be no selling of weapons, explosives, alcohol, tattoos, and illegal items.

*Because of exclusive contracts with our food concessioners, there is to be NO SELLING of foodstuffs to include soft drinks, water, candy, fruits, and similar consumables.*

All Vendors must be in their allowed space-(inside the marked boundaries) Vehicles and trailers are to be parked in designated vendor parking- ....inquire.

Camping on your site allowed- you will be responsible for fees associated with such as determined by Fairground Officials-
